PRODUCT OF THE MONTH

DAYLIFF **WASTELIFT**

SOLAR POWER TRANSFORMS CHP TALEK HEALTH CENTRE



Davis & Shirliff, Huawei, The Maa Trust, and Saruni Basecamp Foundation have jointly donated a 15kW solar power system to **CHP Talek Health Centre**, providing clean, reliable energy for the first time. The system replaces costly diesel generators, significantly cutting down monthly fuel expenses and ending frequent power disruptions. Powering critical medical equipment, refrigeration, and lighting, the system is designed to provide uninterrupted services even during emergencies. "This is a mission-critical upgrade," facility manager Eric Otieno comments. The project supports the center's upgrade to achieving Level 4 hospital status and aligns with national efforts to reduce maternal and child mortality through better healthcare access.
